Violence Against Women Extension Act of 2021

This bill reauthorizes for FY2022 various programs and activities authorized by the Violence Against Women Act of 1994 and subsequent legislation and administered by the Office on Violence Against Women within the Department of Justice.

Actions Timeline

- **May 18, 2021:** Referred to the Subcommittee on Crime, Terrorism, and Homeland Security.
- **May 14, 2021:** Referred to the Subcommittee for Indigenous Peoples of the United States.
- **Mar 16, 2021:** Referred to the Subcommittee on Health.
- **Mar 12, 2021:** Introduced in House
- **Mar 12, 2021:** Referred to the Committee on the Judiciary, and in addition to the Committees on Energy and Commerce, Natural Resources, and Financial Services, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
