Summary (as of Mar 18, 2021)

No Surprise Bills for New Moms Act

This bill requires health insurers to provide coverage for newborns of enrollees for the first 30-day period after the newborn's date of birth and to provide a special enrollment period for the newborn that extends at least 60 days after the initial coverage period. It also requires insurers to notify an enrollee if they receive a claim for the enrollee's newborn who is not enrolled in a health insurance plan.

Actions Timeline

- **Mar 19, 2021:** Referred to the Subcommittee on Health.
- **Mar 18, 2021:** Introduced in House
- **Mar 18, 2021:** Referred to the Committee on Energy and Commerce, and in addition to the Committees on Ways and Means, and Education and Labor, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
- **Mar 18, 2021:** Referred to the Subcommittee on Health.
