## **Medicare Prescription Drug Price Negotiation Act of 2021**

This bill requires the Centers for Medicare & Medicaid Services (CMS) to negotiate with pharmaceutical companies regarding prices for drugs covered under the Medicare prescription drug benefit. Current law prohibits the CMS from doing so.

### **Actions Timeline**

- **Mar 19, 2021:** Referred to the Subcommittee on Health.
- **Mar 18, 2021:** Introduced in House
- **Mar 18, 2021:** Referred to the Committee on Energy and Commerce, and in addition to the Committee on Ways and Means, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
- **Mar 18, 2021:** Referred to the Subcommittee on Health.
