Summary (as of Mar 19, 2021)

COVID-19 Border Protection (CBP) Act

This bill requires the Department of Homeland Security (DHS) to devise and implement a strategy to ensure that no alien with COVID-19 (i.e., coronavirus disease 2019) in DHS or Department of Health and Human Services custody may be released into the community during a public health emergency related to COVID-19.

Funds previously provided to the Department of State for supporting international efforts to help migrants and refugees respond to COVID-19 shall be transferred to DHS to implement this strategy.

Actions Timeline

- **Oct 19, 2021:** Referred to the Subcommittee on Immigration and Citizenship.
- **Mar 20, 2021:** Referred to the Subcommittee on Oversight, Management, and Accountability.
- **Mar 20, 2021:** Referred to the Subcommittee on Border Security, Facilitation, and Operations.
- **Mar 19, 2021:** Introduced in House
- **Mar 19, 2021:** Referred to the Committee on the Judiciary, and in addition to the Committees on Homeland Security, and Foreign Affairs, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
