## National Biomedical Research Act

This bill establishes and makes deposits through FY2030 into the Biomedical Innovation Fund for initiatives at the National Institutes of Health and the Food and Drug Administration. The fund supports (1) research for disease prevention, diagnosis, and treatment; (2) research for diseases that disproportionately account for federal health care spending; (3) the development, review, and post-market surveillance of medical products; and (4) other innovative medical research.
