Bear Protection Act of 2021

This bill prohibits the import, export, and commerce of bear viscera or related products except for limited acts carried out solely to enforce wildlife protection laws.

Actions Timeline

- **Jul 29, 2021:** Subcommittee Hearings Held.
- **Jun 2, 2021:** Referred to the Subcommittee on Water, Oceans, and Wildlife.
- **Apr 1, 2021:** Introduced in House
- **Apr 1, 2021:** Referred to the Committee on Natural Resources, and in addition to the Committees on Foreign Affairs, and Ways and Means, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
