- **Mar 16, 2021:** The resolution provides for one hour of general debate on H.R. 1620, H.R. 6, H.R. 1603, H.R. 1868, and H.J.Res. 17. The resolution provides that H.Res. 232 is hereby adopted.
- **Mar 16, 2021:** Placed on the House Calendar, Calendar No. 11.
- **Mar 16, 2021:** Considered as privileged matter. (consideration: CR H1393-1404)
- **Mar 16, 2021:** DEBATE - The House proceeded with one hour of debate on H. Res. 233.
- **Mar 16, 2021:** POSTPONED PROCEEDINGS - At the conclusion of debate on H. Res. 233, the Chair put the question on ordering the previous question and by voice vote, announced that the ayes had prevailed. Mrs. Fischbach demanded the yeas and nays and the Chair postponed further proceedings on ordering the previous question until at time to be announced.
