Climate Justice Act of 2021

This bill requires the President to establish a Climate Justice Working Group that must advise federal entities on a just and equitable transition towards a clean, climate-resilient, and zero-emission economy.

Actions Timeline

- **Apr 13, 2021:** Referred to the Subcommittee on Environment and Climate Change.
- **Apr 8, 2021:** Introduced in House
- **Apr 8, 2021:** Referred to the Committee on Energy and Commerce, and in addition to the Committee on Natural Resources, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
