Summary (as of Apr 8, 2021)

Temporary Reauthorization of the Emergency Scheduling of Fentanyl Analogues Act

This bill extends until May 6, 2022, the temporary scheduling order issued by the Drug Enforcement Administration to place fentanyl-related substances in schedule I of the Controlled Substances Act. The temporary order expires on May 6, 2021.

Actions Timeline

- Oct 19, 2021: Referred to the Subcommittee on Crime, Terrorism, and Homeland Security.
- Apr 9, 2021: Referred to the Subcommittee on Health.
- Apr 8, 2021: Introduced in House
- Apr 8, 2021: Referred to the Committee on Energy and Commerce, and in addition to the Committee on the Judiciary, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
