Law Enforcement Protection Act of 2021

This bill includes armor-piercing, concealable weapons in the definition of *firearm* under the National Firearms Act.

Actions Timeline

- **Oct 19, 2021:** Referred to the Subcommittee on Crime, Terrorism, and Homeland Security.
- **Apr 13, 2021:** Introduced in House
- **Apr 13, 2021:** Referred to the Committee on Ways and Means, and in addition to the Committee on the Judiciary, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
