Build More Housing Near Transit Act of 2021

This bill revises requirements for the fixed guideway capital investment grant program.

Specifically, the bill revises how the Department of Transportation evaluates and rates fixed guideway capital projects under the program to include affordable housing incentives.

Actions Timeline

- **Apr 15, 2021:** Referred to the Subcommittee on Highways and Transit.
- **Apr 13, 2021:** Introduced in House
- **Apr 13, 2021:** Referred to the Committee on Transportation and Infrastructure, and in addition to the Committee on Financial Services, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
