Summary (as of Apr 13, 2021)

No Taxpayer Funding for Vaccine Passports Act of 2021

This bill prohibits the use of federal funds to develop a system that requires proof of an individual's COVID-19 (i.e., coronavirus disease 2019) vaccination status as a condition of performing any action. If a state, territory, or locality implements such a system, it loses eligibility for specified COVID-19 relief funding.

Actions Timeline

- **Apr 14, 2021:** Referred to the Subcommittee on Health.
- **Apr 13, 2021:** Introduced in House
- **Apr 13, 2021:** Referred to the Committee on Oversight and Reform, and in addition to the Committee on Energy and Commerce, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
