### No Taxpayer Funding for the U.N. Population Fund

This bill prohibits the use of funds to provide contributions directly or indirectly to the United Nations Population Fund (UNFPA). The UNFPA is a United Nations agency that supports access to sexual and reproductive health services, including voluntary family planning, maternal health care, and sexuality education.

- **Apr 30, 2021:** Referred to the Subcommittee on International Development, International Organizations and Global Corporate Social Impact.
- **Apr 13, 2021:** Introduced in House
- **Apr 13, 2021:** Referred to the House Committee on Foreign Affairs.
