Community Protection in Sports Act of 2021

This bill provides localities injured by the cancellation or relocation of certain sporting events a remedy for such action.

Specifically, the bill makes it unlawful for Major League Baseball to cancel or relocate a competition that is not a part of the regular season unless it is a reasonable response to a pandemic, natural disaster, inclement weather, or emergency declared by the federal government or by the state in which the game is scheduled to occur.

A locality that is injured by a violation may commence a civil action for damages from the league for canceling or relocating the game.

Actions Timeline

- **Oct 19, 2021:** Referred to the Subcommittee on Courts, Intellectual Property, and the Internet.
- **Apr 15, 2021:** Referred to the Subcommittee on Consumer Protection and Commerce.
- **Apr 14, 2021:** Introduced in House
- **Apr 14, 2021:** Referred to the Committee on Energy and Commerce, and in addition to the Committee on the Judiciary, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
