Summary (as of Mar 18, 2021)

This resolution urges the U.S. Capitol Police Board to direct the Architect of the Capitol to remove the fencing installed around the perimeter of the U.S. Capitol complex in response to the attacks of January 6, 2021, and it recommends the end of the National Guard's mission in the District of Columbia in response to those attacks.

Actions Timeline

- **Mar 19, 2021:** Referred to the Subcommittee on Economic Development, Public Buildings, and Emergency Management.
- **Mar 18, 2021:** Introduced in House
- **Mar 18, 2021:** Referred to the Committee on Transportation and Infrastructure, and in addition to the Committee on Armed Services, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
