## Summary (as of Apr 16, 2021)

### Amputation Reduction and Compassion Act of 2021 or the ARC Act of 2021

This bill provides for coverage of peripheral artery disease screening tests without cost-sharing under Medicare, Medicaid, and private health insurance for certain at-risk individuals, and requires the development of certain educational programs and Medicare quality measures to reduce amputations relating to such disease.

## Actions Timeline

- **Apr 19, 2021:** Referred to the Subcommittee on Health.
- **Apr 16, 2021:** Introduced in House
- **Apr 16, 2021:** Referred to the Committee on Energy and Commerce, and in addition to the Committee on Ways and Means, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
- **Apr 16, 2021:** Referred to the Subcommittee on Social Security.
- **Apr 16, 2021:** Referred to the Subcommittee on Health.
