Summary (as of Apr 22, 2021)

Pharmacy and Medically Underserved Areas Enhancement Act

This bill provides for Medicare coverage and payment with respect to certain pharmacist services that (1) are furnished by a pharmacist in a health-professional shortage area, and (2) would otherwise be covered under Medicare if furnished by a physician.

Actions Timeline

- Apr 23, 2021: Referred to the Subcommittee on Health.
- Apr 22, 2021: Introduced in House
- Apr 22, 2021: Referred to the Committee on Energy and Commerce, and in addition to the Committee on Ways and Means, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
- Apr 22, 2021: Referred to the Subcommittee on Health.
- Apr 22, 2021: Referred to the Subcommittee on Social Security.
