Summary (as of Apr 22, 2021)

Defending Against Imitations and Replacements of Yogurt, milk, and cheese to Promote Regular Intake of Dairy Everyday Act or the DAIRY PRIDE Act

This bill prohibits the sale of any food that uses the market name of a dairy product (such as *milk*, *yogurt*, or *cream cheese*) unless the food (1) is the milk of a hooved animal, (2) is derived from such milk, or (3) contains such milk as a primary ingredient.

- **Apr 23, 2021:** Referred to the Subcommittee on Health.
- **Apr 22, 2021:** Introduced in House
- **Apr 22, 2021:** Referred to the House Committee on Energy and Commerce.
