## Summary (as of Jan 13, 2021)

### Retired Pay Restoration Act

This bill allows the receipt of both military retired pay and veterans' disability compensation with respect to any service-connected disability. Under current law, only individuals with service-connected disabilities rated at 50% or more receive both without offset.

Individuals who were retired or separated after at least 20 years of military service due to a service-connected disability shall be eligible for the full concurrent receipt of both veterans' disability compensation and either military retired pay or combat-related special pay.

## Actions Timeline

- **Mar 8, 2021:** Referred to the Subcommittee on Disability Assistance and Memorial Affairs.
- **Jan 13, 2021:** Introduced in House
- **Jan 13, 2021:** Referred to the Committee on Armed Services, and in addition to the Committee on Veterans' Affairs, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
