Summary (as of May 7, 2021)

Expanding Contracting Opportunities for Small Businesses Act of 2021

This bill increases the allowable award price for federal government contracts with certain small businesses, including socially and economically disadvantaged small businesses, small businesses owned and controlled by women, and small businesses owned and controlled by service-disabled veterans.

Actions Timeline

- **Jul 26, 2021:** Referred to the Subcommittee on Oversight and Investigations.
- **May 7, 2021:** Introduced in House
- **May 7, 2021:** Referred to the Committee on Small Business, and in addition to the Committee on Veterans' Affairs, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
