## Summary (as of Dec 8, 2021)

This resolution states that the Chinese government is responsible for ongoing abuses against the Uyghurs and other ethnic and religious minority groups and that these abuses constitute genocide and crimes against humanity. The resolution also condemns such genocide and crimes against humanity and calls on the President to take certain actions to put an end to these atrocities.

## Actions Timeline

- **Dec 8, 2021:** Mr. Meeks moved to suspend the rules and agree to the resolution, as amended.
- **Dec 8, 2021:** Considered under suspension of the rules. (consideration: CR H7507-7509)
- **Dec 8, 2021:** DEBATE - The House proceeded with forty minutes of debate on H. Res. 317.
- **Dec 8, 2021:** At the conclusion of debate, the Yeas and Nays were demanded and ordered. Pursuant to the provisions of clause 8, rule XX, the Chair announced that further proceedings on the motion would be postponed.
