Actions Timeline

- **Apr 20, 2021:** Introduced in House
- **Apr 20, 2021:** The House Committee on Rules reported an original measure, H. Rept. 117-22, by Mr. Raskin.
- **Apr 20, 2021:** The previous question on each measure is considered ordered without intervening motions except one hour of debate and a motion to recommit. H. Res. 316 and H. Con. Res. 30 are adopted.
- **Apr 20, 2021:** Placed on the House Calendar, Calendar No. 14.
- **Apr 20, 2021:** Considered as privileged matter. (consideration: CR H1968-1976)
- **Apr 20, 2021:** DEBATE - The House proceeded with one hour of debate on H. Res. 330.
- **Apr 20, 2021:** POSTPONED PROCEEDINGS - At the conclusion of debate on H. Res. 330, the Chair put the question on ordering the previous question and by voice vote, announced that the ayes had prevailed. Mr. Reschenthaler demanded the yeas and nays and the Chair postponed further proceedings on ordering the previous question until a time to be announced.
