Summary (as of May 20, 2021)

Substance Use Disorder Workforce Act

This bill increases the number of residency positions eligible for graduate medical education payments under Medicare for hospitals that have addiction or pain medicine programs, with an aggregate increase of 1,000 positions over a five-year period.

Actions Timeline

- **May 21, 2021:** Referred to the Subcommittee on Health.
- **May 20, 2021:** Introduced in House
- **May 20, 2021:** Referred to the Committee on Ways and Means, and in addition to the Committee on Energy and Commerce, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
