#### **Increasing Access to Osteoporosis Testing for Medicare Beneficiaries Act of 2021**

This bill specifies that certain Medicare payment rules applicable to imaging services shall apply to dual-energy x-ray absorptiometry services used in bone mass scans beginning in 2022.

The Centers for Medicare & Medicaid Services must establish national minimum payment amounts for such services.

### Actions Timeline

- **May 26, 2021:** Referred to the Subcommittee on Health.
- **May 25, 2021:** Introduced in House
- **May 25, 2021:** Referred to the Committee on Energy and Commerce, and in addition to the Committee on Ways and Means, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
