#### **Northern Border Reopening Transparency Act**

This bill requires the Department of Homeland Security to submit a report on considerations relating to easing restrictions on or reopening the United States-Canada border to essential and nonessential travel.

### Actions Timeline

---

- **Nov 1, 2022:** Referred to the Subcommittee on Immigration and Citizenship.
- **Jun 9, 2021:** Referred to the Subcommittee on Border Security, Facilitation, and Operations.
- **Jun 8, 2021:** Introduced in House
- **Jun 8, 2021:** Referred to the Committee on Homeland Security, and in addition to the Committees on Ways and Means, Foreign Affairs, and the Judiciary, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
- **Jun 8, 2021:** Referred to the Subcommittee on Trade.
