## Summary (as of Jun 14, 2021)

This bill establishes the Alzheimer's Research and Caregiving Trust Fund to pay for research regarding the treatment or cure of Alzheimer's disease and for education, counseling, respite, and other supportive services for individuals with Alzheimer's disease and their families, caregivers, and health care professionals.

The bill allows taxpayers an election to contribute a whole dollar amount to the trust fund when they file their tax returns.

## Actions Timeline

- **Jun 15, 2021:** Referred to the Subcommittee on Health.
- **Jun 14, 2021:** Introduced in House
- **Jun 14, 2021:** Referred to the Committee on Ways and Means, and in addition to the Committees on Energy and Commerce, and Education and Labor, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
