Summary (as of Jun 15, 2021)

Blue Carbon Protection Act

This bill establishes programs, grants, and requirements to protect and restore marine and blue carbon ecosystems, which are vegetated coastal habitats and include mangroves, tidal marshes, and other tidal or salt-water wetlands that have the capacity to sequester and store carbon.

Actions Timeline

- **Jun 22, 2021:** Committee Hearings Held.
- **Jun 17, 2021:** Referred to the Subcommittee on Water, Oceans, and Wildlife.
- **Jun 16, 2021:** Referred to the Subcommittee on Environment.
- **Jun 15, 2021:** Introduced in House
- **Jun 15, 2021:** Referred to the Committee on Natural Resources, and in addition to the Committee on Science, Space, and Technology, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
