## Summary (as of Jun 16, 2021)

### Segal AmeriCorps Education Award Tax Relief Act of 2021

This bill modifies the requirements for calculating taxable income to exclude from gross income any AmeriCorps educational awards provided under the National and Community Service Act of 1990.
