Summary (as of May 19, 2021)

This resolution sets forth the rule for consideration of H.R. 3233 (National Commission to Investigate the January 6 Attack on the United States Capitol Complex Act) and H.R. 3237 (Emergency Security Supplemental to Respond to January 6th Appropriations Act, 2021).

Actions Timeline

- **May 19, 2021:** Considered as privileged matter. (consideration: CR H2563-2571)
- **May 19, 2021:** DEBATE - The House proceeded with one hour of debate on H. Res. 409.
- **May 19, 2021:** POSTPONED PROCEEDINGS - At the conclusion of debate on H. Res. 409, the Chair put the question on ordering the previous question and by voice vote, announced that the ayes had prevailed. Mr. Cole demanded the yeas and nays and the Chair postponed further proceedings until a time to be announced.
- **May 19, 2021:** Considered as unfinished business. (consideration: CR H2573-2574)
- **May 19, 2021:** On ordering the previous question Agreed to by the Yeas and Nays: 217 - 208 (Roll no. 151). (consideration: CR H2573-2574)
- **May 19, 2021:** Passed/agreed to in House: On agreeing to the resolution Agreed to by the Yeas and Nays: 216 - 208 (Roll no. 152). (text: CR H2563)
