Summary (as of Jun 23, 2021)

Reducing Hereditary Cancer Act of 2021

This bill provides for Medicare coverage of germline mutation testing for individuals with a personal or family history of a hereditary cancer gene mutation or suspected history of hereditary cancer, as well as for associated coverage of risk-reducing surgeries and screenings.

Actions Timeline

- Jun 24, 2021: Referred to the Subcommittee on Health.
- Jun 23, 2021: Introduced in House
- Jun 23, 2021: Referred to the Committee on Energy and Commerce, and in addition to the Committee on Ways and Means, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
- Jun 23, 2021: Referred to the Subcommittee on Health.
