Insulin Access for All Act of 2021

This bill prohibits cost-sharing (e.g., copayments) under Medicaid and the Medicare prescription drug benefit for insulin and associated medical supplies.

Actions Timeline

- **Jun 25, 2021:** Referred to the Subcommittee on Health.
- **Jun 24, 2021:** Introduced in House
- **Jun 24, 2021:** Referred to the Committee on Energy and Commerce, and in addition to the Committee on Ways and Means, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
- **Jun 24, 2021:** Referred to the Subcommittee on Health.
