International Trafficking Victims Protection Reauthorization Act of 2022

This bill reauthorizes certain initiatives to combat human trafficking (e.g., the Trafficking Victims Protection Act of 2000) and specifically incorporates anti-human trafficking initiatives into other federal programs and activities (e.g., the U.S. Agency for International Development).
