## Summary (as of Jul 13, 2021)

### Farm System Reform Act of 2021

This bill places a moratorium on large concentrated animal feeding operations; requires country-of-origin labeling for beef, pork, and dairy products; and otherwise revises provisions related to the marketing of livestock, poultry, and meat.

## Actions Timeline

- **Aug 11, 2021:** Referred to the Subcommittee on Livestock and Foreign Agriculture.
- **Jul 14, 2021:** Referred to the Subcommittee on Water Resources and Environment.
- **Jul 13, 2021:** Introduced in House
- **Jul 13, 2021:** Referred to the Committee on Agriculture, and in addition to the Committee on Transportation and Infrastructure, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
