### Summary (as of Jul 16, 2021)

## Facilitating Innovative Nuclear Diagnostics Act of 2021

This bill establishes separate payment requirements for diagnostic radiopharmaceuticals under the Medicare prospective payment system for hospital outpatient department services. The bill's requirements apply to diagnostic radiopharmaceuticals that have an average daily cost of \$500 or more in 2022 and as adjusted based on a specified fee schedule factor in each year thereafter.

## Actions Timeline

- Jul 19, 2021: Referred to the Subcommittee on Health.
- Jul 16, 2021: Introduced in House
- Jul 16, 2021: Referred to the Committee on Energy and Commerce, and in addition to the Committee on Ways and Means, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
- Jul 16, 2021: Referred to the Subcommittee on Health.
