## Healthy Forests for Hunters Act of 2021

This bill establishes categorical exclusions from environmental review requirements under the National Environmental Policy Act of 1969 for certain forest management activities relating to early successional forests or outdoor recreation.

- **Jul 20, 2021:** Referred to the Committee on Natural Resources, and in addition to the Committee on Agriculture, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
