## Summary (as of Jun 11, 2021)

---

This resolution addresses issues involving LGBTQI+ identifying people.

Specifically, the resolution

- calls on the Department of State, the U.S. Agency for International Development, and other federal agencies to include the promotion of equal rights for LGBTQI+ identifying people in their work;
- condemns discrimination, persecution, and violence against LGBTQI+ identifying people;
- calls on governments across Europe and Eurasia to foster safe and equitable environments for all people; and
- urges the U.S. government to increase funding for LGBTQI+ human rights organizations in Europe and Eurasia.

## Actions Timeline

---

- **Nov 1, 2022:** Referred to the Subcommittee on the Constitution, Civil Rights, and Civil Liberties.
- **Jun 11, 2021:** Introduced in House
- **Jun 11, 2021:** Referred to the Committee on Foreign Affairs, and in addition to the Committee on the Judiciary, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
