Summary (as of Jul 27, 2021)

Military Spouse Tax Act

This bill provides that a spouse of a service member may retain their personal residence or domicile for purposes of taxation.

The bill authorizes a service member and the spouse of the member to elect to use the following locations for purposes of taxation:

- the residence or domicile of the member,
- the residence or domicile of the spouse, or
- the permanent duty station of the member.

- **Jul 27, 2021:** Introduced in House
