Summary (as of Jan 25, 2021)

Ally's Act

This bill requires private health insurance plans to cover certain hearing devices and systems (e.g., bone-anchored auditory implants) and related items and services. The bill also imposes limits on cost sharing.

Actions Timeline

- **Feb 2, 2021:** Referred to the Subcommittee on Health.

- **Jan 25, 2021:** Referred to the Committee on Energy and Commerce, and in addition to the Committees on Education and Labor, and Ways and Means, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
