Summary (as of Jul 29, 2021)

Safe School Drinking Water Act

This bill requires the Environmental Protection Agency to establish a program to award grants to assist local educational agencies in installing and maintaining filtration stations (e.g., drinking fountains) at schools and child care programs.

Actions Timeline

- **Jul 29, 2021:** Referred to the House Committee on Energy and Commerce.
