Summary (as of Aug 10, 2021)

No Federal Funding for Confederate Symbols Act

This bill prohibits federal funds from being used for the creation, maintenance, or display of any Confederate symbol on federal public land or other federal property.

An exception to such prohibition is provided (1) if the use of such funds is necessary to allow for the removal of the Confederate symbol to address public safety; or (2) in the case of a Confederate symbol created, maintained, or displayed in a museum or educational exhibit.

- **Aug 11, 2021:** Referred to the Subcommittee on Aviation.
- **Aug 11, 2021:** Referred to the Subcommittee on Coast Guard and Maritime Transportation.
- **Aug 11, 2021:** Referred to the Subcommittee on Economic Development, Public Buildings, and Emergency Management.
- **Aug 11, 2021:** Referred to the Subcommittee on Highways and Transit.
- **Aug 11, 2021:** Referred to the Subcommittee on Railroads, Pipelines, and Hazardous Materials.
- **Aug 11, 2021:** Referred to the Subcommittee on Water Resources and Environment.
- **Aug 10, 2021:** Introduced in House
- **Aug 10, 2021:** Referred to the Committee on Natural Resources, and in addition to the Committees on Armed Services, and Transportation and Infrastructure, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
