### Woman on the Twenty Act of 2021

This bill bars the printing of any \$20 note after December 31, 2024, which does not prominently feature a portrait of Harriet Tubman on the front face of the note.

The Department of the Treasury shall release to the public the preliminary design of the \$20 note prominently featuring a portrait of Harriet Tubman no later than December 31, 2022.
