#### **Water Advanced Technologies for Efficient Resource Use Act of 2021**

This bill provides statutory authority for the WaterSense program of the Environmental Protection Agency (EPA) and sets forth related requirements. Under the program, the EPA awards grants to provide incentives for consumers to purchase water-efficient products.

### Actions Timeline

---

- **Oct 1, 2021:** Referred to the Subcommittee on Environment and Climate Change.
- **Sep 30, 2021:** Introduced in House
- **Sep 30, 2021:** Referred to the Committee on Ways and Means, and in addition to the Committees on Energy and Commerce, and Oversight and Reform, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
