## **Dr. Joanne Smith Memorial Rehabilitation Innovation Centers Act**

This bill directs the Centers for Medicare & Medicaid Services to publish and biennially update a list of all rehabilitation innovation centers. The bill defines *rehabilitation innovation centers* as rehabilitation facilities that (1) hold specified federal research and training designations for traumatic brain injury or spinal cord injury research, and (2) serve at least a certain number of Medicare patients.

### **Actions Timeline**

---

- **Oct 6, 2021:** Referred to the Subcommittee on Health.
- **Oct 5, 2021:** Introduced in House
- **Oct 5, 2021:** Referred to the Committee on Ways and Means, and in addition to the Committee on Energy and Commerce, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
- **Oct 5, 2021:** Referred to the Subcommittee on Health.
