Summary (as of Oct 8, 2021)

Indian Health Service Advance Appropriations Act

This bill authorizes advance appropriations for the following Indian Health Service appropriations accounts:

- Indian Health Services,
- Indian Health Facilities,
- Contract Support Costs, and
- Payments for Tribal Leases.

The advance appropriations provide new budget authority that first becomes available in the first fiscal year after the budget year. The bill requires the President's budget request to include information on estimates for the advance appropriations.

Actions Timeline

- **Jul 28, 2022:** Subcommittee Hearings Held.
- **Oct 15, 2021:** Referred to the Subcommittee for Indigenous Peoples of the United States.
- **Oct 11, 2021:** Referred to the Subcommittee on Health.
- **Oct 8, 2021:** Introduced in House
- **Oct 8, 2021:** Referred to the Committee on Natural Resources, and in addition to the Committees on Energy and Commerce, and the Budget, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
