Let Me Travel America Act

This bill prohibits operators of trains, buses, planes, and other common carriers that transport passengers interstate from denying service based on individuals' COVID-19 vaccination status. The bill also prohibits federal agencies from making COVID-19 vaccination a prerequisite for interstate travel.

Actions Timeline

- **Oct 20, 2021:** Referred to the Subcommittee on Aviation.
- **Oct 19, 2021:** Introduced in House
- **Oct 19, 2021:** Referred to the Committee on Energy and Commerce, and in addition to the Committee on Transportation and Infrastructure, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
