### Summary (as of Oct 20, 2021)

#### Foreign Merger Subsidy Disclosure Act of 2021

This bill requires entities to disclose in their premerger notification filings to federal antitrust regulators a detailed accounting of any economic support they received from a foreign state.

### Actions Timeline
