## Summary (as of Nov 1, 2021)

### Expanding Access to Diabetes Self-Management Training Act of 2021

This bill expands Medicare coverage of diabetes outpatient self-management training. It also requires the Center for Medicare and Medicaid Innovation to test a model in which such training is provided virtually.

## Actions Timeline

- **Nov 2, 2021:** Referred to the Subcommittee on Health.
- **Nov 1, 2021:** Introduced in House
- **Nov 1, 2021:** Referred to the Committee on Energy and Commerce, and in addition to the Committee on Ways and Means, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
- **Nov 1, 2021:** Referred to the Subcommittee on Health.
