Summary (as of Nov 4, 2021)

Keeping Our COVID-19 Heroes Employed Act

This bill exempts essential workers from COVID-19 vaccination requirements imposed by the federal government and contractors, public entities that received federal COVID-19 relief funds, and private entities that received any federal funds.

An *essential worker* is an individual who was deemed to be essential or exempted from response measures during the COVID-19 pandemic by a state, tribe, or territory.

Actions Timeline

- **Nov 5, 2021:** Referred to the Subcommittee on Health.
- **Nov 4, 2021:** Introduced in House
- **Nov 4, 2021:** Referred to the Committee on Energy and Commerce, and in addition to the Committee on Oversight and Reform, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
- **Nov 3, 2021:** Sponsor introductory remarks on measure. (CR H6131)
