Summary (as of Nov 4, 2021)

Rural Health Fairness in Competition Act

This bill requires the Centers for Medicare & Medicaid Services (CMS) to establish a Medicare Rural Health Clinic Value-Based Care Program that exempts certain rural health clinics (e.g., those participating in Medicare quality programs) from payment limitations if they meet reporting requirements relating to quality measures and performance standards, as set by the CMS.

Actions Timeline

- **Nov 5, 2021:** Referred to the Subcommittee on Health.
- **Nov 4, 2021:** Introduced in House
- **Nov 4, 2021:** Referred to the Committee on Energy and Commerce, and in addition to the Committee on Ways and Means, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
- **Nov 4, 2021:** Referred to the Subcommittee on Health.
