Supporting Medicare Providers Act of 2021

This bill extends a payment increase under the Medicare physician fee schedule through 2022.

Actions Timeline

- **Nov 19, 2021:** Referred to the Subcommittee on Health.
- **Nov 18, 2021:** Introduced in House
- **Nov 18, 2021:** Referred to the Committee on Energy and Commerce, and in addition to the Committee on Ways and Means, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
- **Nov 18, 2021:** Referred to the Subcommittee on Health.
